

Amelia Franck Meyer Ed.D, LISW Chief Executive Officer, Alia Innovations

Dr. Amelia Franck Meyer is the Founder and CEO of the national non-profit, Alia. Amelia and Team Alia are leading a nationally co-designed movement to keep children safe with, not from, their families. Amelia was named as one of People Magazine's "25 Women Changing the World" in 2018, and in 2020, was named by AARP MN and Pollen Midwest as a 50over50 Honoree—System Reformer in the Disruptor Category. Amelia has a widely viewed TEDx Talk on the Human Need for Belonging and has also received the prestigious honors of being named a Bush Fellow and an Ashoka Fellow.

Amelia and Team Alia believe that "Families are the solution" (not the problem). Alia calls this new way of work an "UnSystem". Team Alia believes that a key part of transformation is supporting families to safely raise their children. Working with innovative leaders, Amelia and Team Alia use best practices, evidence, and human centered design principles to operationalize concepts that produce rapid results and positive outcomes for youth and families.

### Director, Division of Family Well-Being and Protection for the Iowa Department of Health and Human Services

Janee C. Harvey serves as the Director, Division of Family Well-Being and Protection for the Iowa Department of Health and Human Services. She worked as a social worker in New York, NY, for more than a decade before transplanting to Des Moines, IA, in 2015 with her wife and two kids. She is a graduate of Hunter College with a Master of Social Work (MSW) and is credentialed as a Licensed Clinical Social Worker (LCSW) and Licensed Independent Social Worker (LISW). She has worked with runaway and homeless teens, LGBTQ youth, and families, children and youth involved with the child welfare system for the past 20 years. Most recently, she has served for the last four years as the Child Welfare and Community Services Bureau Chief for DHS and has been the Division Administrator over Adult, Children and Family Services (ACFS) since 2015. "Janee's energy and deep love of policy is remarkable and is exactly what we need as we move to implement Family First federal legislation," said Director Kelly Garcia. "She's the right person at this important time as we focus on strengthening families through evidence-based practices and services designed to keep families together. She will also work to highlight the importance of child protective services."

As a licensed special education teacher, professional school counselor, trauma expert, author, and leader in the movement to build trauma-sensitive schools, Ms. Jen has more than 20 years of experience providing support to young people and the educators who serve them.

In her current role as consultant and facilitator of professional development, Ms. Jen shows educators what works and why when it comes to building trauma-sensitive learning environments. Within minutes of interacting with her, educators know they are learning from someone who understands the real struggles of everyday teaching and learning—and believe that change benefiting educators, students, and entire school communities is possible.

Jonathan Davis is a Training Specialist at Project Harmony and has been in the child welfare field for the past 8 years. Prior to working as a trainer, Jonathan has worked as a case manager, visitation specialist and family support worker.
